According to the latest findings, four in ten businesses (39%) report having cyber security breaches or attacks in the last 12 months.


However, most common cyber-attacks are looking for targets which do not have the Cyber Essentials technical controls in place.

The Process – How we work

The remote audit is then carried out, any issues are dealt with and resubmitted for audit.
